The <u>PLAN Test</u> will be administered to all freshman. The PLAN Test is a practice test for the American College Test. The ACT is a required admissions test for many colleges. The PLAN also helps to identify career interests and relates these to educational and training requirements.

To:

The <u>ACT Aspire</u> will be administered to all sophomores and freshmen. The Aspire is part of a longitudinal assessment system, normed by grade level, for college and career readiness that is developed by American College Test (ACT). The ACT is a required admissions test for many colleges. BBHHS seeks to provide students with the best opportunities for practice of the skills needed for performance on the high stakes testing.
