COUNTY SERVICE AGREEMENT CITY, EXEMPTED VILLAGE and LOCAL SCHOOL DISTRICTS O.R.C. 3313.843

The Educational Service Center of Cuyahoga County (ESCCC), 5811 Canal Road., Valley View, OH 44125 and the Brecksville/Broadview Hts Schools Board of Education do hereby agree to implement the following county services as per O.R.C. 3313.843 in the 2013-2014 school year in the service area as listed below:

Brecksville/Broadview Hts Schools Service Areas may include:

- Supervision of Teaching Staff
 - Special Education
 - General Education
 - Gifted & Talented
- In-service and continuing education programs for district personnel
- Research and Development programs
- Curriculum Services
- Academic instruction for which the Governing Board employs teachers pursuant to Section 3319.02 of the Ohio Revised Code (ORC)
- Assistance in the provision of special accommodations and classes for students with disabilities
- Any other service the District's Board of Education and the ESCCC Governing Board agree can be better provided by the Educational Service Center

The ESCCC and Brecksville/Broadview Hts Schools enter into a primary agreement upon the following:

- 1. The effective date of implementation of the above services in any approved service area shall be from July 1, 2013 through June 30, 2014.
- 2. Upon request of the city/exempted village/local school district, the ESCCC shall employ appropriate personnel who will be assigned to the service area according to the philosophy, values, and needs of the city/exempted village/local district.

- 3. The City/Exempted Village/Local Board of Education shall pay the ESCCC for all net costs (if not covered by City/County Agreement funds) to employ personnel specified. The ESCCC shall invoice the City/Exempted Village/Local Board of Education for said net costs. Said net costs shall include cost of employee leave and substitute personnel, SERS surcharge (if any), salary, workers' compensation, unemployment compensation, severance, Medicare, retirement, liability insurance, life insurance, and health benefits attributable to the Governing Board Should any subsequent unemployment compensation or severance claim be made by an employee covered under this contract, the City/Exempted Village/Local school district herein receiving the services shall be so liable for their proportionate share of the employee's claim. The City/Exempted Village/Local school district accepts the responsibility of conducting annual evaluation (s) of administrative, classified and certified employees pursuant to Section 3319.01, 3319.02, 3319.11 and 3319.111 of the Ohio Revised Code.
- 4. The city/exempted village/local district agrees to a deduction from their State Foundation payments in the amount of \$6.50 per pupil plus any additional contracted services beyond the deduct plus an apportioned amount computed by the State Department of Education for county supervisors or personnel among all city/exempted village/local districts served.
- 5. A continuous accounting of fund balances shall be kept by the ESCCC and reported to the city/exempted village/local districts. Unexpended balances may be carried over to the next fiscal year.
- 6. Any apportioned amount deducted for supervisory services for the city/exempted village/local district wherein said service is not rendered shall be credited to the account of said district for use in the other service areas specified in O.R.C. 3313.843.
- 7. Ninety percent 90% of the State Share per pupil funds only received by ESCCC plus 100% of the deduct per pupil amount to the ESCCC will be available for services to the city/exempted village/local district. In the event that an agreement is not continued in any ensuing year, the unexpended balance shall remain with the ESCCC.
