### **Use of Funds**


Brecksville Broadview Heights City School District anticipates to allocate 100% of the Student and Wellness funds to the contract for the Behavior and Wellness Specialist through the partnership with the Education Service Center of Northeast Ohio (ESC) and ABA Outreach.

### **Community Partners and Roles**

Brecksville Broadview Heights City School District partners with the Education Service Center of Northeast Ohio (ESC) to contract the Behavior Wellness Specialist as well as assists with providing continued professional development regarding mental health resources and support for students.

### **Progress Measures**

The progress of the effectiveness of the use of the Behavior Wellness Specialist in assisting the needs of our students in the area of mental health will be evaluated through the referrals and process through the MTSS process in addition to the PLC meetings with the Behavior Wellness Specialist and Pupil Service Administration Staff monthly where qualitative data will analyzed. This will assist with any mid year and final year adjustments that are needed.



## Personnel Responsible and Roles

### Behavior/Wellness Specialist

The Behavior/Wellness Specialist provides the following to each of their buildings:

- Partners with School Counselors to provide tiered support
- Partners with our Clinical Counselors through Nancy & Lowry for referrals and additional support
- Partners with our BCBA to provide tiered levels of support
- Partners with BCBA, Counselors and MTSS teams to provide case manager support for students on behavior plans/tiered support.
- Partners with MTSS teams in the buildings regarding supporting mental health needs and/or behavior supports related.
- Provides Professional Development and support to staff regarding Trauma informed care, behavior strategies and mental health awareness and supports.
- Members of IEP, 504 teams provide consultation and interventions to support behavior and mental health needs.

## **Identify District Include Data and Evidence of Need**

Brecksville Broadview Heights City School District has experienced an increase in behaviors relating to student mental health needs. Student's that have been referred to the District through the MTSS team to show a need for either tier 2 or 3 interventions.

## **District Strategies/Programs/Services**

Brecksville Broadview Heights City School District has a partnership with the Education Service Center of Northeast Ohio (ESC) and ABA Outreach to provide services through a Coordinator of Behavior/Wellness Support Services (Behavior/Wellness Specialists). The District has contracted three Behavior/Wellness Specialists for the District, which allows for one specialist in each of the buildings. The Behavior/Wellness Specialist provides the following to each of their buildings:

- Partners with School Counselors to provide tiered support
- Partners with our Clinical Counselors through Nancy & Lowry for referrals and additional support
- Partners with our BCBA to provide tiered levels of support
- Partners with BCBA, Counselors and MTSS teams to provide case manager support for students on behavior plans/tiered support.

The purpose of this programming is to provide tiered support to students in an effort to provide preventative and intervention care to students with mental health needs that are impacting their behavior and performance to assist students in being provided in the least restrictive environment.

# ABA Outreach 23-24 Impact Overview

## **Services**

- 1 Daily BCBA Support
- 2 Daily RBTs (Registered Behavior Technicians for individual students)
- 1 Daily RBT for 2 hrs daily with 1 individual student

## **Professional Development**

- 4 total presentations (completed/scheduled)
  - 1 for Classroom Assistants
  - 1 for Elementary Intervention Specialists & Related Service providers
  - 1 for Preschool Intervention Specialists
  - 1 for High School Intervention Specialists

## **Impact of ABAs Services**

- 32 Students Directly Impacted through Consultation or FBA/BIP created
- ABA also provide coaching in 5 high needs classrooms
