As an agency with Cuyahoga County district superintendents on our Board, we are keenly aware of the fiscal realities schools are facing. Our budget is developed with that in mind, and we make it a priority to keep costs at their lowest while providing quality comprehensive services.

Like many school districts, PEP is experiencing the effects of reduced funding. The state is implementing significant cuts in Medicaid that directly affect PEP. Like you, we are carefully managing resources to balance the loss. Rates for the 2015-2016 school year reflect a 3% increase.

PEP is committed to offering value-added services to school districts at low cost or at no cost. This summer, as always, PEP is operating weekly psychiatric clinics for students receiving psychiatric services at PEP. The service is free of charge to districts. Case managers are on call and will be actively working throughout the summer.

PEP Assist is a service offered to districts aimed at maintaining challenging students in the district. PEP Assist services are available through full year contracts or on an as needed basis for consultation or training.

PEP Connections offers mental health services to children and youth throughout the County for children ages 3-17. To be eligible for PEP Connections services, the student must have a diagnosis of a serious emotional disturbance (SED). Students who have not had a mental health assessment, but show evidence of SED will be offered an assessment to determine eligibility. All school districts in Cuyahoga County can make referrals to PEP Connections. These mental health and assistance services are available at no charge to the district.
